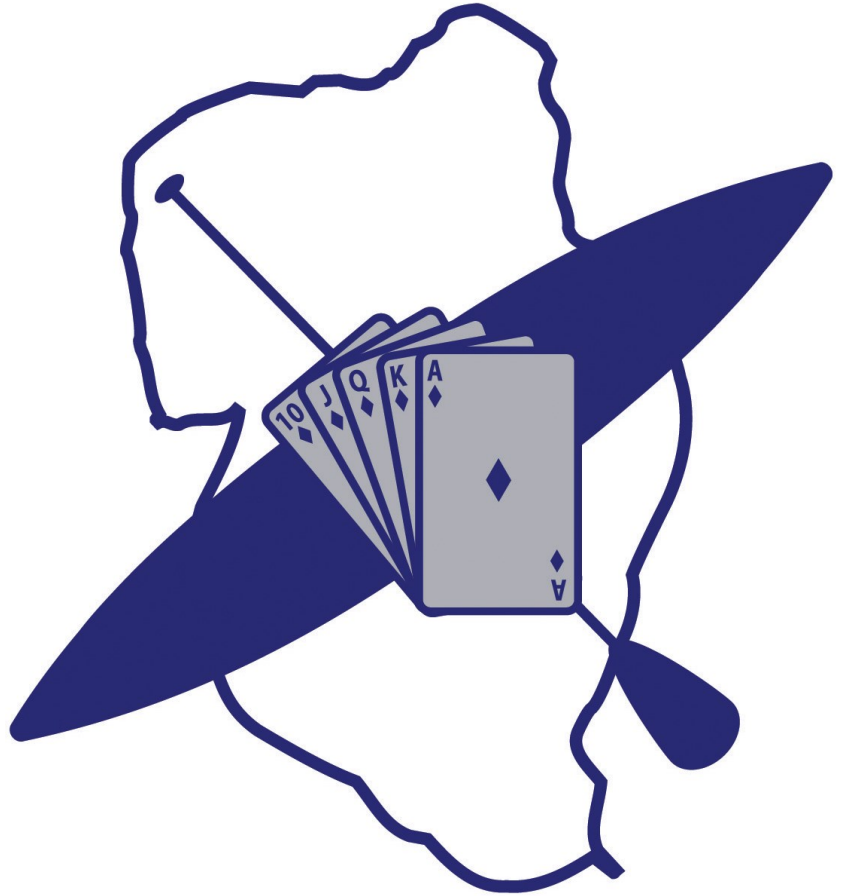

This year there will only be one route from the Town Park to Long Point. The Poker Run is scheduled to start at 6:00 p.m. sharp!

Every person on your craft who has a paddle must be registered to participate. There is a **\$10.00 registration** fee through July 8th. Anyone wishing to register after July 8th will need to pay a \$15.00 registration fee. If you wish to register on the day of the event, you must be there by 5:30 pm.

No worries, no hurry, just stay on the route and enjoy the lake, pick up your five cards from the stations marked with colored flags, bring your poker hand back to the launch area and register your cards with the event coordinator by 7:00. Winners will be announced at 7:10.

2015 CULVER LAKE FEST CANOE/KAYAK/SUP POKER RUN  
AGREEMENT TO PARTICIPATE JULY 17TH, 2015  
RELEASE OF LIABILITY & ASSUMPTION OF RISK

In consideration of being allowed to participate in any way in the Culver Lake Fest Canoe/Kayak/SUP Poker Run, I, as participant (the Releasor), hereby acknowledge, appreciate, and agree that: The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular skills, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and

I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and

I willing agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the Organizations (Culver Lake Fest or LMEC) immediately; and

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS THE Organizations named above, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used for the activity (Releasees) WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property associated with my presence or participation, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OF OTHERWISE, to the fullest extent permitted by law.

I further stipulate and agree that the terms of this Agreement will apply to any minors accompanying me, that I am either the parent, legal guardian, or otherwise have direct and express permission from the minor's family for the minor to accompany and for me to enter into this Agreement releasing the minor's legal rights and/or remedies, that I assume all risk and responsibility for such minors in accompanying me, and that I agree to indemnify and defend the Releasees for any loss, liability, damage or cost they may incur due to the presence of the minor on the canoe or kayak during this program, whether caused by the negligence of the Releasees or otherwise.

I further stipulate and agree, that while participating in the canoeing, kayaking, or SUP to be bound by all orders rules, and directions of the Releasees.

**THERE IS A TEN DOLLAR (\$10.00) REGISTRATION FEE WHICH MUST ACCOMPANY THIS FORM. IF PAID BY JULY 8TH YOU WILL RECEIVE AN EVENT HAT IF YOU ARE ONE OF THE FIRST TEN TO REGISTER. DAY OF EVENT REGISTRATION FEE IS \$15. THE RACE WILL BEGIN AT 6:00 P.M. SO "DAY OF" REGISTRATION WILL BEGIN AT 5:30 P.M. TIMES FOR THIS EVENT WILL VARY DUE TO PADDLER RATE AND LAKE CONDITIONS. ALL ENTRANTS MUST RETURN AND CHECK IN WITH THE EVENT ORGANIZERS BY 7:00 P.M. SO THAT EVERYONE IS ACCOUNTED FOR AT THE END OF THIS EVENT. CULVER LAKE FEST OR THE EVENT SPONSORS ARE NOT RESPONSIBLE FOR THE WATER CONDITIONS, ROUTES, OR OTHER ACTIVITIES OF PARTICIPANTS OR THEIR EQUIPMENT.**

Adult MUST sign this liability release form. Children MUST wear life jackets when on the water. If a minor is participating it will be assumed that they can swim once this waiver is signed by an adult. Anyone under the age of 18 must be accompanied by an adult.

Absolutely NO littering in the lake. Please take everything you bring with you when you leave or dispose of it in an approved trash bin.

All participants must sign in with the event registrar before and after the event to be eligible to win.

Stay within the buoys.

Respect private property and others on the lake. Wear sneakers or water shoes for wading. Take plenty of fluids (not in glass containers)

Be aware of water hazards; swim at your own risk.

What is taken with you may get wet or possibly lost - this will be your responsibility.
